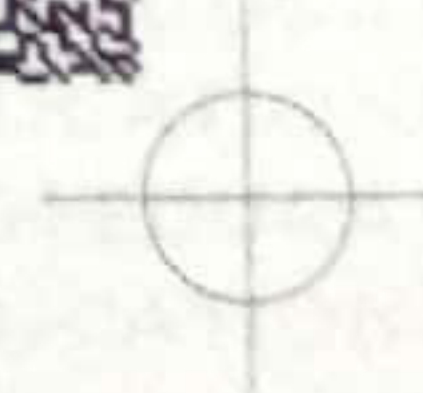
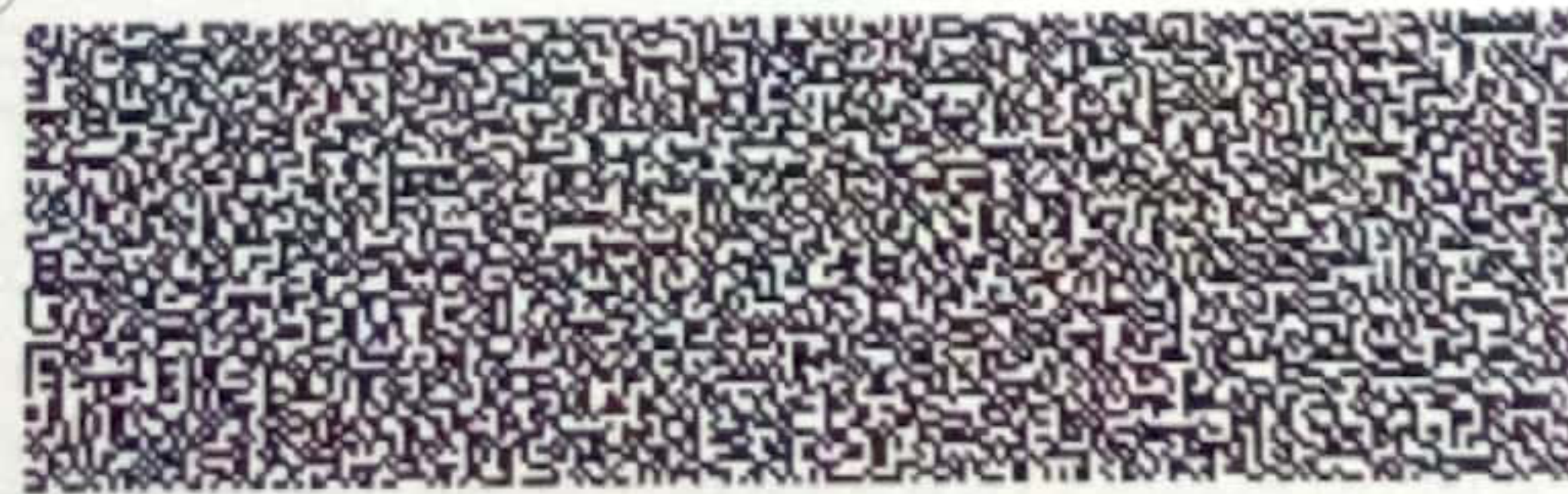

The Donar has identified the following points in preparing the "Programme Action"


1. Deployment of Teachers for the Subjects, Sports and co-curricular activities and providing Teaching aids based on the requirement and necessity at the school

The Donar and the representatives of the Department has together agreed to implement "Programme action"




